Director of Instructional Services, Lisa Warne, explained that ELOP funds are provided by state for after school and summer school programs to address the needs of students at risk. The Charter School will be expanding the day to provide a before school and after school program. The district is also exploring a partnership with ECC for Summer School. Partnering, the Mark West Union School District would host the first, 3 week session followed by a July session hosted by the ECC.

Though the program would focus on students at risk, the program would be open to all students. The program would begin in the 2022-2023 school year though this year, Summer School would be funded through ESSR III

funding provided by the American Rescue Plan Act to address student needs and the impact of learning loss.
