- Trustee Sherwood reported that the website for the Mark West Citizens Action Council shows the progress
 on the sidewalk along Mark West Springs Rd. between John B. Riebli and Old Redwood Highway. A
 champion of the cause, former Superintendent, Ron Calloway, was instrumental in bringing this process to
 fruition. Once completed, the walkway will provide safe access along Mark West Springs Rd. for students,
 families and the community.
- Our students chose the wording that will be reflected on the concrete benches along the walkway.
- The Hawk Light has been installed in front of the Larkfield Center and it should be operational soon.
- The community raised the funding to install an ADA compliant walkway around Schopflin Park.
- A commemoration of the 5 year anniversary of the Tubbs fire was held this past weekend. The event was
 attended by many community members including Dr. Valenzuela. Trustee Sherwood spoke as a "block
 captain" of his community. In his speech, he recognized all of the first responders including educators
 adding that "Dr. Valenzuela's voice and then Superintendent Calloway's videos were instrumental in
 keeping the district together after the fires." Dr. Valenzuela added that the "shout out to educators was
 deeply felt,"
