San Miguel has an experienced staff dedicated to ongoing professional development and continuous inquiry. At the core of this dedication is a belief that collaboration is key to student achievement. Student data is used as a guide in adjusting instruction. Conversations focus on working with every student by name and need. We look to creating life long learners who are community-minded. The school offers rigorous academic instruction in all the core subject areas. Enrichment (formerly Gifted and Talented Instruction), music, intervention, English Language Development, and arts education are provided to students as determined by student need and interest. Student progress is monitored through the use of formative assessments. Staff meets three times per year to review student results during Co-op meetings. In these meetings, teachers will discuss next steps in classroom, intervention, and Enrichment. Additionally staff comes together once a month for school-specific professional development such as curriculum review, technology integration, common core implementation, and school safety. In all of these professional development opportunities, staff demonstrates their dedication to collaboration and working in partnership with students and families to improve teaching and learning.

School wide positive behavior management is embraced by teachers, students, yard duty supervisors, and community. There are weekly assemblies, in which students are recognized and honored for demonstrating character traits.

2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

For the current year 2023-24, the school has met the sufficiency of textbooks or other instructional materials. The Reading/Language Arts and Mathematics textbooks were selected from SBE adoption recommendations and were adopted by the district school board. The school district will be exploring SBE-recommended updated textbooks and instructional materials for forthcoming Science and Social Studies textbook adoptions. In addition to the Wonders/Study Sync language arts program, teachers also use Writing By Design to supplement the writing curriculum. Also, in addition to the McGraw Hill science curriculum the district has purchased a license to use the Mystery Science program. The district is planning to adopt a new science curriculum at the end of the school year pending a recommendation to the school board and approval.

2023-24 School Safety Plan

San Miguel Charter School has a comprehensive school safety plan that follows SIMS and NEMS guidelines. It is in line with the Mark West District Safety Plan. The plan is reviewed at the beginning of each school year with the entire staff. Safety inspections are done routinely by the maintenance department, especially prior to school opening.

In case of an emergency, staff roles are outlined in the comprehensive plan. A "flip-book" of emergency responses for various situations and drill procedures are kept in an obvious location in each classroom. Classrooms and all common areas (library, computer lab, and MPR, for example) are equipped with a red emergency bag containing first aid supplies.

Fire, earthquake and shelter-in-place drills are practiced routinely.

Each year, the San Miguel Charter School Site Council reviews the District Safety and Wellness plans and policy and also they review the San Miguel Charter School BEST Plan. The San Miguel Charter School BEST Plan is the behavior expectation and discipline plan for the school. BEST is an acronym for Building Effective Schools Together. It is a system, which gives staff, students, and community a structure to support strong character development, expected behaviors, and have fair discipline consequences. We look at discipline data, target areas for student training, and celebrate student successes. BEST is part of the PBIS system, is research-based and builds from "what already works" in a school.

Positive Discipline is based on the following principles: mutual respect (I respect myself and I respect you), all people strive for belonging and significance, mistakes are opportunities to learn, logical and natural consequences that are reasonable, related, and respectful help people own and grow from mistakes, and children will develop competencies when we provide them with

responsibilities and support. Violations of expectations will be addressed in a positive, respectful, reasonable and related manner. Keeping in mind that mistakes are opportunities to learn and grow, consequences will be issued on a severity continuum and can include a conference with the teacher, phone call to the parent, written reflection or apology, conflict mediation, behavior plan, loss of privileges, suspension, or expulsion.

Fiscal Year 2022-23 Types of Services Funded

San Miguel employs Response to Intervention (RTI) and has programs and services to be able to provide differentiated support for students. In Kindergarten and first grades, an instructional assistant provides one hour of support for reading groups. In grades K-3, a Title 1 Reading Teacher provides extra support for those students needing more than first instruction. In each classroom, grades 2-6 each have 1 hour of paraprofessional time. The paraprofessional's main goal is to help students with the greatest need. All grade 3 students are tested for GATE qualification. In grades 4-6, students are divided into groups which support Enrichment (formerly Gifted and Talented Instruction), small group support, and intervention. Currently, San Miguel has a full time credentialed intervention teacher who targets specific skills for students who are needing them. English Learners, who are academically struggling, are provided with additional English Language Development instruction. Students with the most severe learning needs are provided with special education services. The district continues to provide counseling services for students who are having school adjustment difficulties or to provide support in times of family crisis. San Miguel has its own counselor dedicated to it.

Professional Development

Our staff development program is aligned with the district and school site's goals and priorities. We support certificated personnel throughout the district to plan together and attend workshops on best practices for standards based instruction. With the state adoption of the Common Core State Standards and a shift in assessment to a computer based assessment, the primary focus for staff development has been implementation of the Common Core State Standards. In addition, this year our district is looking at updating and reviewing our MTSS (multi tiered systems of support), San Miguel is specifically looking at PBIS (Positive Behavior Intervention and Supports) In support of our English Language Learners, staff has received additional training in assisting EL's in meeting the CCSS. In alignment with our Strategic Plan, the district has provided support in the form of a Project Based Learning support teacher who goes into each classroom coaching and supporting teachers in planning and implementing project based learning in the classroom. All staff are receiving training and support in the area of Social Emotional Wellbeing through our Director of Student Services and Counselors. The district relies heavily on the support of the County Office of Education, which provides a wide range of professional development opportunities in implementation of CCSS and Next Generation Science Standards (NGSS). We utilize early release days, known as "site days" and "district days" as well as faculty meetings to provide training for staff. With the adoption of a new Common Core aligned math program, an area of focus during early release days has been in support of mathematics. The new English Language Arts curriculum is in its third year of implementation, and teachers have appreciated the online component, especially during Distant Learning due to COVID. In addition to the training provided by the district, many teachers spent time learning new online learning platforms and software utilized during Distant Learning. All new teachers participate in the North Coast Teacher Induction Program through Sonoma County Office of Education during their first two years of teaching. These classes are held after school hours and each new teacher is assigned an experienced mentor for the entire process. More experienced teachers participate in training
