- Trustee McKnight attended the Santa Rosa City Schools Meeting presentation regarding the final report on the proposed study of consolidation. A consolidation would have a negative impact on the Mark West Union School District on many levels.

- 91% of 2<sup>nd</sup>-6<sup>th</sup> graders hit their AR goals
- 6<sup>th</sup> graders went to science camp
- 5<sup>th</sup> graders are working on their site reports
- 1st graders walked safely to the LBC on the new sidewalks
- Staff is busy with coops and report cards
- PTA sponsored a very successful Bingo Night

Kelli Osorio, Mark West Elementary

- Shout out to Patrick Eagle for scheduling all of the district sports
- 3<sup>rd</sup> graders will be going to the Planetarium at Piner High School
- The 3<sup>rd</sup> grade Green Team is partnering with a senior center in Healdsburg expanding their community outreach of the program
- Engineer, Carlos Diaz, made a presentation involving erosion effects to the 6<sup>th</sup> graders
- Mr. Ryan hosted a Handball Tournament
- Student teachers are doing really well

Patrick Eagle, San Miguel Elementary

- TK has reached the letter "P"
- 5<sup>th</sup> graders head to Angel Island tomorrow and Thursday
- 6<sup>th</sup> graders are studying their rocketry unit
- Girls basketball vs Mark West Elementary; double overtime, Mark West Elementary won Michelle Franci, Mark West Charter School
  - PTA events include: Night at the Sharks, Warriors Night and Bowling Night
  - Walk-a-Thon is April 19<sup>th</sup>
  - Coops today. At the last MTSS training we determined decision rules. Applied and worked with those rules today; adjustments to be made
  - 27% of students had 5 or more tardies in the first semester. The site implemented a "positive reinforcement theme" and percentage of students with 5 or more tardies dropped to 12%
- **8.2** Director of Maintenance/Operation/Technology/Michael Smith Mr. Smith will present an Oral Report
  - Mr. Smith reported on the phone system failure. Moved to servers that have SSD. Bottom line is that if one server fails, the second server will automatically come online to cover.
- 8.3 Director of Instructional Services/Lisa Warne Superintendent Valenzuela will present an Oral Report on behalf of Ms. Warne
  - Ms. Warne was attending a conference and therefore, Dr. Valenzuela presented on her behalf.
  - ELPAC testing has begun. This process informs teachers of students current language acquisition status
  - Students are piloting 2 different Science curriculums. Adoption committee will then gather input from students
  - Teachers are preparing for SBAC
  - We recently hosted a PBIS workshop for parents in English and Spanish
  - A Reading and Literacy workshop was held for parents in February
  - In March we will host an SBAC workshop for parents in English and Spanish

  - Last month's top two social media posts our 3 fantastic counselors and Chinese New Year celebrations. Posts accumulated 50 "likes" each.

  - Shout out to our two labor unions! As we work in partnership with each, the comfort level for all
    has increased and we continue to maintain a collaborative manner in which we work with each
    other
  - Now that all staff has been informed about MTSS, information will be added to the District website
  - February 21<sup>st</sup>, Santa Rosa City School held a Special Board Meeting to discuss the results of the Consolidation Survey they had solicited. The report found that a consolidation plan is possible *if a reasonable financial plan is developed.* As districts move forward with "opt out", there will be less cost savings for Santa Rosa City Schools. Attorneys have drafted a Resolution and suggested that it would be fine for feeder districts that could be affected, to notify Santa Rosa City Schools by resolution, that they are not interested in moving forward with the process. The Board requested that the Resolution be placed on the April Agenda for approval.
  - Dr. Valenzuela noted that she attended the Winter Music Concert; there were two sessions and both were packed houses. Wonderful concert! The quality of music that students are playing under the direction of Kara Kaufman, is phenomenal!
