 - We need approximately 7 8, 1st grade students to enroll in order to eliminate the need for combo classes
 - o 4th grade has the highest numbers across the district
- Dr. Valenzuela presented information on the consideration of expansion at Mark West Charter School. She provided an update to the Board with a focus on the SWOT analysis (Strengths, Weaknesses, Opportunities, and Threats). Parents of current 5th/6th graders were surveyed. There is some interest from our current 6th families in regards the possible 7th grade expansion of Mark West Charter School for the 2025-2026 school year. Also, current 5th grade families expressed interest in attending Mark West Charter School when their child is eligible to attend middle school. Other feedback included: interest in sports, construction and space are all areas that would need to be addressed. Additional steps need to be taken before a final decision is made,
